O Regulations on the Amounts of Tuition, Admission and Entrance Examination Fees and Rents at the Kobe University

(Established on April 1, 2004)

(Purpose)

Article 1 These rules set forth necessary matters concerning the amounts of tuition, admission and entrance examination fees and rents at the Kobe University (hereinafter referred to as "University"), in accordance with the provisions of Article 52 of the National University Corporation Kobe University Accounting Regulations (established on April 1, 2004).

(Amounts of Tuition, Admission and Entrance Examination Fees)

Article 2 The amounts of tuition fees (or childcare fees at kindergarten; the same shall apply hereinafter), and admission fees (or kindergarten enrolment fees at kindergarten; the same shall apply hereinafter) charged by the University are set forth in the following table.

2. Pursuant to the provisions of paragraph 4 of Article 22 of the Kobe University General Rules for Students (hereinafter referred to as "General Rules for Students") (including the case where provisions apply with necessary modifications under Article 72 of the General Rules for Students), the annual amount of tuition fees collected from a person who is permitted to complete curricula and graduate or complete a course of study according to a concrete plan over a certain period of time that exceeds the maximum or standard course duration at the University shall, irrespective of the provisions of the preceding paragraph and only for the permitted period of enrollment in the University (hereinafter referred to as "period of long-term enrollment"), be determined by multiplying the annual amount of tuition fees stipulated in the preceding paragraph by the number of years corresponding to the maximum or standard course duration at the University, divided by the number of years of long-term enrollment (rounded up to the nearest 10 yen).

3. In cases where faculties conduct screening of applicants based on submitted documents, etc. (hereinafter referred to as "first-stage screening" in this and following paragraphs) and conduct selection by means of academic achievement tests only for applicants who pass first-stage screening (hereinafter referred to as "second-stage screening" in this and following paragraphs), the amounts of entrance examination fees shall, irrespective of the provisions of paragraph 1, be 4,000 yen for first-stage screening (or 2,200 yen for faculties with night classes), and 13,000 yen for second-stage screening (or 7,800 yen for faculties with night classes).

4. In the case where first-stage screening is conducted for applicants for Department of Professional Legal Studies in the Graduate School of Law, and second-stage screening is conducted only for applicants who have passed first-stage screening, the amounts of entrance examination fees shall, irrespective of the provisions of paragraph 1, be 7,000 yen for first-stage screening, and 23,000 yen for second-stage screening.

5. In cases where examinations, health checks, screening based on documents, etc. are conducted for admission to an elementary school, junior high school, former course of secondary school, and elementary school or junior high school programs in the school for children with intellectual disabilities, the amounts of entrance examination fees shall be as described in the following table.

6. In cases where screening processes for admission to the kindergarten, latter course of the secondary school, and senior high school program of the school for children with intellectual disabilities, as stipulated in paragraph 1, or admission to elementary school, former course of the secondary school, and elementary or junior high school programs of the school for children with intellectual disabilities, as stipulated in the preceding paragraph, involve drawing of lots, etc. (hereinafter referred to as "examinations, etc."), the amounts of entrance examination fees shall, irrespective of the provisions of paragraph 1 and the preceding paragraph, be as described in Column 2 of the following table for screening by drawing of lots, and in Column 3 of the same table for examinations, etc.

7. The amount of entrance examination fees for a person who applies for admission to the University by way of transfer between faculties, mid-course entry, or re-admission shall, regardless of the provisions of paragraph 1, be 30,000 yen (or 18,000 yen for faculties with night classes).

8. The amount of tuition fees for a person admitted by way of mid-course entry, transfer between faculties, or re-admission shall be the same amount as for those who are enrolled in the same academic year as that in which such person is enrolled.

9. Pursuant to the provisions of the proviso of paragraph 1 of Article 16 of the Standards for Establishment of Graduate Schools (Ordinance of the Ministry of Education No. 28 of 1974), the amount of tuition fees for a person who completes a master's program at a graduate school and immediately advances to the graduate school's doctoral program shall be equal to the amount for those enrolled in the same academic year as that in which such person is enrolled. (Amounts of Rents)

Article 3 The amounts of rents charged by the University shall be as described in the following table.

2. Necessary matters concerning amounts of rents, additional to those provided for in this Article, shall be prescribed separately.

Supplementary Provisions

These rules shall come into effect on April 1, 2004.

Supplementary Provisions (March 31, 2005)

These rules shall come into effect on March 31, 2005 and shall apply as of tuition fees for the 2005 academic year.

Supplementary Provisions (September 30, 2007) These rules shall come into effect on April 1, 2007.

Supplementary Provisions (March 13, 2008)

These rules shall come into effect on April 1, 2008, and the provisions of the Regulations on the Amounts of Tuition, Admission and Entrance Examination Fees and Rents at the Kobe University, as amended, shall apply as of December 26, 2007.

Supplementary Provisions (March 25, 2009) These rules shall come into effect on April 1, 2009.

Supplementary Provisions (June 28, 2011) These rules shall come into effect on June 28, 2011.

Supplementary Provisions (March 27, 2013) These rules shall come into effect on April 1, 2013. Supplementary Provisions (March 26, 2014) These rules shall come into effect on April 1, 2014.
