### 'New Opportunities for EU-Japan Research & Innovation Cooperation' 21 October 2021, 8:45-12:40(CEST) /15:45-19:40 (JST) - Online Event -

This workshop and brokerage event follows-up and complements the 11<sup>th</sup> Kobe University-VUB Annual Symposium *'Green Horizons, Sustainable Futures: EU-Japan Research for Climate-Prepared, Resilient Societies'* held the previous day. This 'hands-on' workshop is primarily addressed to European researchers and research managers from UniILION Member Universities interested in collaborating with Japanese research organisations.

**Session 1** will update participants on the latest developments in R&I between Europe and Japan, at the policy and funding levels. It will highlight opportunities for Japanese participation in Horizon Europe and introduce Japanese funding programmes for international collaboration. It will look, in particular, at 'bridges' being developed between Horizon Europe and other Japanese research programmes. It will also consider new instruments developed in the perspective of the Association of Japan to Horizon Europe and other recent initiatives. (e.g. EU-Japan Green Alliance)

**In session 2**, the three Japanese members of UniILION will share their experiences and identify concrete opportunities for collaboration with Europe, especially with UnILiON member Universities. RIKEN, Japan's largest research organization will also present its programmes.

In the ensuing **discussion session** presenters from Kobe, UnILiON and industry will share their own experience on the challenges and opportunities of working with Japanese and European organisations. Participants will share, in particular, lessons learned from participating in EU and Japanese calls.
