# RULES OF THE KOBE UNIVERSITY INTERNATIONAL RESIDENCE AND INTERNATIONAL HOUSE

#### ARTICLE I ESTABLISHMENT

The Kobe University International Residence and International House (hereinafter referred to as the Residence) are established in Kobe University (hereinafter referred to as the University).

## ARTICLE II PURPOSE

The Residence is provided for use by international students and researchers in order to help promote international communication in the educational, research, and cultural areas.

## ARTICLE III ACCOMMODATION AND FACILITIES OF THE RESIDENCE

The Residence offers accommodation to international students (hereinafter referred to as student accommodation) and accommodation to international researchers (hereinafter referred to as researchers accommodation).

#### ARTICLE IV ADMINISTRATIVE DIRECTOR

- Paragraph 1. The President of the University shall be the administrative director of the Residence.
- Paragraph 2. The Kobe University International Student Council shall deliberate the important matters concerning the administration of the Residence.

## ARTICLE V RESIDENT ADVISOR

- Paragraph 1. The Residence is able to have a resident advisor.
- Paragraph 2. The Resident Advisor shall give guidance and advice to the resident international students and researchers on matters relating to their study, research and daily life.

## ARTICLE VI QUALIFICATIONS FOR RESIDENCE

Paragraph 1. The following persons shall be eligible for admission to the student accommodation:

- 1. International students registered at the University, and their families.
- 2. Others approved by the President of the University.

Paragraph 2. The following persons shall be eligible for admission to the researcher accommodation:

- 1. International researchers who are engaged in teaching or research at the University, and their families.
- 2. Others approved by the President of the University.

#### ARTICLE VII APPLICATION PROCEDURE

A person desiring accommodation in the Residence shall submit to the President of the University an application for admission on Form 1.

## ARTICLE VIII RENTS AND CHARGES

Paragraph 1. Of those accommodated in the Residence (hereinafter referred to as the residents),

international students must pay rents as provided for in Article 3 of the Regulations on the Amounts of Tuition, Admission and Entrance Examination Fees and Rents at the Kobe University (established on April 1, 2004), and international researchers must pay charges according to the appended table before the scheduled date of payment.

Paragraph 2. Rents and charges shall be non-refundable.

Paragraph 3. In addition to rents, the residents must pay for utilities according to the schedules established elsewhere.

#### ARTICLE IX USE OF THE FACILITIES

Residents and their accompanying families must exercise their discretion in maintaining the residence facilities and equipment in good condition.

#### ARTICLE X INDEMNIFICATION FOR LOSS OR DAMAGE

If the resident or his/her family is responsible for loss or damage of any residence facilities and/or equipment, he/she shall make indemnification for such loss or damage or restore the said facilities or equipment to their original condition.

#### ARTICLE X I WITHDRAWAL OF ACCOMMODATION APPROVAL

Paragraph 1. The President of the University has the right to rescind the approval of accommodation in the Residence if the resident:

- 1. Lose the qualifications for residence stated in Article VI.
- 2. Fails to pay rents and charges stated in Article VII.
- 3. Fails to fulfill responsibilities stated in the preceding Articles.
- 4. Has caused or is determined liable to cause grave hindrance to the normal administration of the Residence.

Paragraph 2. The University shall not be responsible for any loss suffered by the resident due to withdrawal of accommodation approval according to the previous paragraph.

#### ARTICLE X II VACATING PROCEDURE

The resident vacating the unit must submit the appropriate "Notification of Departure" form to the President of the University.

#### ARTICLE X III ADMINISTRATION

Administrative matters relating to the Residence shall be handled by the International Student Exchange Division.

## ARTICLE XIV OTHER PROVISIONS

Other provisions concerning the administration of the Residence shall be specified separately.

## SUPPLEMENTARY PROVISION

The present Regulations shall be effective as of April 1,2004.
