1.3. Kobe University Interdisciplinary Master Program in Global Business Law (KIMAP in Global Business Law)

In the field of international business, the ability to be able to function in English is a prerequisite that goes hand in hand with possessing specialized knowledge. Therefore, the goals of this program are, in addition to providing interdisciplinary knowledge in business administration and economics as well as specialized skills and knowledge in law, to equip students with practical English skills and to produce talented individuals that can be successful as international legal business practitioners.

Professional Degree Programs

Without a doubt, professional legal education in Japan not only needs quantitative expansion but also qualitative improvement. Our society requires many highly capable legal professionals, especially in the face of increasing diversity, technological advancements, rapid globalization and marketization. With this in mind, the Kobe University Graduate School Law's Professional Legal Studies Program sets forth the following two principle educational objectives.

The first objective of the program is to train legal professionals who will acquire the basic knowledge and advanced practical skills that all legal professionals must have. There is tremendous amount of fundamental knowledge that is sine qua non for all legal professionals. The Law School at Kobe University aims to cultivate such professionals so that they gain the required knowledge, along with the ability to appropriately apply it to an increasingly diversified society.

The second objective of the program is to train legal professionals that have, in addition to the knowledge on the basic legal fields described above, an in-depth knowledge as well as applicable skills in the advanced field of corporate transactions in the broadest sense (so-called "Business Law"). Business transactions are becoming increasingly complex as a result of technological advances and society's increased marketization. Consquently legal disputes have also become more complex and sophisticated. The Law School at Kobe University aims to train professionals with the skills necessary to settle such legal disputes, by offering high quality education on a wide range of legal fields.

In order to cultivate legal professionals with extensive professional skills and the know-how necessary to achieve these goals, the program offers an internationally competitive education based on advanced research and awards Doctor of Jurisprudence (Professional) / Juris Doctor (Professional) degrees according to the following policies.

Degree: Juris Doctor

Japan's society will require many more capable legal professionals as diversification, technological advances, internationalization, and society's rapid marketization progress. In order to meet this demand, the Graduate School Law's Professional Legal Studies Program will confer degrees in accordance with the following policies, based on the Kobe University Diploma Policy.

- Students will be enrolled in the program for a designated duration and obtain all the necessary credits required for graduation.
- Prior to completion of this program, students will achieve the following academic goals in order to become legal professionals, in addition to those required by the Kobe University Diploma Policy.
 - The necessary basic knowledge and practical skills for all legal professions.
 - · Knowledge and practical skills in advanced legal fields that deal with business law.
 - The high ethical standards required as a legal professional.
 - Competency to solve new problems by examining as well as a critically and creatively advancing the approaches of legal thinking .
 - The ability to solve problems while respecting and acknowledging diverse ideas and different cultures in society.
